Dear Shareholder,

I am writing to inform you that this year's AGM of Dillistone Group Plc will be held on Wednesday 23 September 2020 at 10.30 a.m. at 12 Cedarwood, Crockford Lane, Chineham Business Park, Basingstoke RG24 8WD. Details of the business to be considered are set out in the notice of meeting ("**Notice**") which follows this letter. I should like to make some comments on a number of the matters to be dealt with at the AGM.

Resolutions 2, 3 & 4 – Re-election of Directors

These resolutions concern the re-election of Mike Love, Giles Fearnley, Jason Starr, are retiring at the Meeting by rotation in accordance with article 83 of the Company's articles of association. Mike Love and Giles Fearnley are retiring as they have served as non-executive directors for nine years or more and must offer themselves annually for re-election under article 83. The Board of Directors of Dillistone ("**Board**" or "**Directors**"), following its evaluation of the performance of the Directors offering themselves for re-election, confirms that each of the Directors is performing effectively and demonstrates commitment to their role.

Resolutions 5 & 6 Election of Directors

Paul Mather and Simon Warburton have been appointed by the Board since the Company's last annual general meeting. According to the Company's articles of association, Directors appointed in this manner are required to offer themselves for election at the next annual general meeting, and accordingly Paul and Simon will do so at the Meeting. The Board, following its evaluation of the performance of the Directors offering themselves for election, confirms that each of the Directors is performing effectively and demonstrates commitment to their role.

Resolution 9 – Directors' power to allot shares

Section 549 of the Companies Act 2006 (the "**Act**") stipulates that directors cannot allot shares or rights to subscribe for shares in a company (other than the shares allotted in accordance with an employees' share scheme) unless they are authorised to do so by its shareholders in general meeting. The Directors' current authority to allot shares was granted at last year's annual general meeting and is due to expire at the conclusion of the Meeting. Resolution 9 seeks new authority from shareholders (to the exclusion of the previous general authority granted at last year's annual general meeting) for the Directors to allot relevant securities up to an aggregate nominal value £327,800 (equating to 6,556,000 ordinary shares of 5p each in the share capital of the Company). This general authority equates to approximately one-third of the nominal value of the issued share capital of the Company. The Directors do not have any present intentions of exercising this authority, but they consider it desirable that the specified amount of unissued share capital is available for issue so that they can more readily take advantage of possible opportunities. Unless renewed, revoked, varied or extended, this authority will expire at the conclusion of the next annual general meeting of the Company.

Resolution 10 – Directors' power to allot shares for cash

Resolution 10 authorises the Directors in certain circumstances to allot equity securities for cash other than in accordance with statutory pre-emption rights (which require a company to offer all allotments for cash first to existing shareholders in proportion to their holdings). The relevant circumstances are either where (i) the allotment takes place in connection with a rights issue or (ii) the allotment is limited to a maximum nominal amount of £147,510 (equating to 2,950,200 ordinary shares of 5p each in the share capital of the Company), representing approximately 15 per cent. of the nominal value of the issued ordinary share capital of the Company. Unless renewed, revoked, varied or extended, this authority will expire at the conclusion of the next annual general meeting of the Company. Resolution 10 will also give the Directors power to sell Ordinary Shares held in treasury on a non pre-emptive basis, subject always to the limitations noted above. The Directors consider that the power proposed to be granted by Resolution 10 is necessary to retain flexibility, although they do not have any intention at the present time of exercising such power.

Resolution 11 – Authority to purchase shares (market purchases)

Under Resolution 11, which is proposed as a special resolution, the Company will seek to renew the current limited authority to make purchases in the market of its own Ordinary Shares subject to specified limits, including the minimum and maximum prices which may be paid. The maximum number of Ordinary Shares which the Company may purchase pursuant to this authority is limited to 1,966,802 Ordinary Shares, representing approximately 10 per cent. of the issued share capital of the Company.

In seeking this authority the Board is not indicating any commitment to buy back Ordinary Shares. The Board will only exercise the authority if, in the light of market conditions prevailing at the time, it considers that the purchases of Ordinary Shares can be expected to result in an increase in earnings per share and be in the best interests of shareholders generally. The Directors do, however, consider it desirable for this authorisation to be available to provide flexibility in the management of the Company's capital reserves. In the event of any purchase under this authority, the Directors would either hold the purchased Ordinary Shares in treasury or cancel them. The authority will expire at the conclusion of the next annual general meeting of the Company.

Shareholders are advised to check the Company's website for updates.

The health of the Company's shareholders, as well as its officers and employees is of paramount importance. It is expected that the Company's attendance in person at the AGM will be limited to satisfy the requirements of a quorum, in line with guidance issued by ICSA and the FRC. The AGM will end immediately following the formal business required and there will be no corporate presentations, Q&A or refreshments. Any Board members in attendance will not meet with shareholders individually who attempt to attend the AGM. Social distancing measures will be in place and strict hygiene arrangements in force. Instead of attending the AGM, shareholders are therefore requested to participate in the AGM by proxy. The Board strongly urges shareholders to comply with Government public health instructions in respect of the evolving situation regarding COVID-19. Please note that the Company currently intends to refuse entry to shareholders who do attempt to attend the AGM in order to comply with those public health instructions.

Votes on the resolutions will be taken by way of a poll rather than on a show of hands. Accordingly, all shareholders are encouraged to vote by proxy and appoint the chairman of the meeting as their proxy for this purpose. You may appoint a proxy by completing and returning the Proxy Form that accompanies these report and accounts.

Recommendation

Your Board considers each of the proposed resolutions to be in the best interests of the Company and its shareholders as a whole. Accordingly, your Directors unanimously recommend that you vote in favour of the resolutions as they intend to do in respect of their own beneficial shareholdings amounting to 5,306,724 Ordinary Shares representing approximately 26.98 per cent. of the issued share capital of the Company.

Notice of Annual General Meeting

Notice is hereby given that the Annual General Meeting (the “**AGM**” or “**Meeting**”) of Dillistone Group Plc (the “**Company**”) will be held at 12 Cedarwood, Crockford Lane, Chineham Business Park, Basingstoke RG24 8WD on Wednesday 23 September 2020 at 10.30 a.m. for the following purposes:

Ordinary Resolutions

To consider and, if thought fit, pass the following resolutions, which will be proposed as ordinary resolutions:

1. Report and accounts

To receive the audited annual accounts of the Company for the year ended 31 December 2019, together with the directors’ report and the auditor’s report on those annual accounts.

2. Re-election of Director

To re-elect Mike Love, who has served twelve years on the Board as a non-executive director and who must offer himself for re-election annually in accordance with the Company’s articles of association.

3. Re-election of Director

To re-elect Giles Fearnley, who has served nine years on the Board as a non-executive director and who must offer himself for re-election annually in accordance with the Company’s articles of association.

4. Re-election of Director

To re-elect Jason Starr, who retires by rotation in accordance with the Company’s articles of association.

5. Election of Director

To elect Paul Mather, who, having been appointed since the last annual general meeting of the Company, offers himself for election in accordance with the Company’s articles of association.

6. Election of Director

To elect Simon Warburton, who, having been appointed since the last annual general meeting of the Company, offers himself for election in accordance with the Company’s articles of association.

7. Re-appointment of auditors

To appoint BDO as auditors of the Company to hold office from the conclusion of this Meeting until the conclusion of the next general meeting at which accounts are laid before the Company.

8. Auditors’ remuneration

To authorise the Directors to determine the remuneration of the auditors.

9. Directors' authority to allot shares

That, in substitution for any equivalent authorities and powers granted to the Directors prior to the passing of this resolution, the Directors be and they are generally and unconditionally authorised pursuant to Section 551 of the Companies Act 2006 (the "**Act**") to exercise all powers of the Company to allot shares in the Company, and grant rights to subscribe for or to convert any security into shares of the Company (such shares, and rights to subscribe for or to convert any security into shares of the Company being "**relevant securities**") up to an aggregate nominal amount of £327,800 provided that, unless previously revoked, varied or extended, this authority shall expire on the conclusion of the annual general meeting of the Company to be held in 2021 except that the Company may at any time before such expiry make an offer or agreement which would or might require relevant securities to be allotted after such expiry and the Directors may allot relevant securities in pursuance of such an offer or agreement as if this authority had not expired.

Special Resolutions

To consider and, if thought fit, pass the following resolutions which will be proposed as special resolutions.

10. Directors' power to allot shares for cash

That the Directors be and they are empowered pursuant to Section 570(1) of the Act to allot equity securities (as defined in Section 560(1) of the Act) of the Company wholly for cash pursuant to the authority of the Directors under Section 551 of the Act conferred by resolution 7 above and/or by way of a sale of treasury shares (by virtue of Section 573 of the Act), in each case as if Section 561(1) of the Act did not apply to such allotment, provided that:

- (a) the power conferred by this resolution shall be limited to:
 - (i) the allotment of equity securities in connection with an offer of equity securities to the holders of ordinary shares in the capital of the Company in proportion as nearly as practicable to their respective holdings of such shares, but subject to such exclusions or other arrangements as the Directors may deem necessary or expedient in relation to fractional entitlements or legal or practical problems under the laws of, or the requirements of any regulatory body or any stock exchange;
 - (ii) the allotment, otherwise than pursuant to sub-paragraph (i) above, of equity securities up to an aggregate nominal amount of £147,510; and
- (b) unless previously revoked, varied or extended, this power shall expire on the conclusion of the annual general meeting of the Company to be held in 2021 except that the Company may before the expiry of this power make an offer or agreement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of such an offer or agreement as if this power had not expired.

11. Authority to purchase shares (market purchases)

That the Company be and it is generally and unconditionally authorised to make market purchases (within the meaning of Section 693(4) of the Act) of ordinary shares of 5 pence each of the Company provided that:

- (a) the maximum number of ordinary shares hereby authorised to be acquired is 1,966,802,
- (b) the minimum price which may be paid for any such share is 5 pence (exclusive of expenses);
- (c) the maximum price (exclusive of expenses) which may be paid for any such shares is an amount equal to 110 per cent. of the average of the middle market quotations for an ordinary share as derived from the London Stock Exchange Daily Official List for the five business days immediately preceding the day on which the ordinary share is contracted to be purchased; and

- (d) the authority hereby conferred shall expire at the conclusion of the annual general meeting of the Company to be held in 2021, save that the Company may, prior to the expiry of such authority, make an offer or agreement which would or might require ordinary shares to be purchased by the Company after such expiry and the Company may purchase ordinary shares notwithstanding such expiry.

1. A member who is entitled to attend, speak and vote may appoint a proxy to attend, speak and vote instead of him. 4. Pursuant to regulation 41 of the Uncertificated Securities Regulations 2001, the Company specifies that only those persons registered in the register of members of the Company at 6.00 p.m. on 21 September 2020 (or if the AGM is adjourned, 48 hours (excluding, in the calculation of such time period, any part of a day that is not a working day) before the time fixed for the adjourned AGM) shall be entitled to attend and vote at the AGM in respect of the number of shares registered in their name at that time. Any changes to the register of members after such time shall be disregarded in determining the rights of any person to attend or vote at the AGM.
5. As at 14 August 2020 (being the latest practicable date prior to publication of this document) the Company's issued share capital consists of 19,668,021 ordinary shares, carrying one vote each. Therefore, the total voting rights in the Company as at 14 August 2020 are 19,668,021.
6. Completion and return of a form of proxy does not preclude a member from attending and voting at the AGM or at any adjournment thereof in person.
7. In the case of joint holders, the signature of only one of the joint holders is required on the form of proxy but the vote of the first named on the register of members will be accepted to the exclusion of the other joint holders.
8. A member that is a company or other organisation not having a physical presence cannot attend in person but can appoint someone to represent it. This can be done in one of two ways: either by the appointment of a proxy (described in Note 1 above) or of a corporate representative. Members considering the appointment of a corporate representative should check their own legal position, the Company's articles of association and the relevant provisions of the Companies Act 2006.
